

Decor Steals Giveaway Official Rules

1. **NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN.**

2. **ELIGIBILITY:** This giveaway is open to legal residents of the United States (excluding Alaska, Hawaii, and Rhode Island) and the District of Columbia, 18 years of age and older as of January 20, 2022, except for employees of Décor Steals LLC (“**Sponsor**”), its affiliates, subsidiaries, and agencies (collectively, the “**Promotion Parties**”), and members of their immediate family or persons living in the same household. Void where prohibited.

3. **HOW TO ENTER:** Beginning on January 20, 2022 at 8:00 am EST, log on to decorsteals.com/5kgiveaway.html and follow the on-screen entry instructions. Fill in all required information and submit your entry. You may enter only once. No more than one entry per email address is permitted. Use of any robotic, automatic, programmed, or similar entry method or entering more than the number of times permitted will void all entries and result in disqualification. You may not enter more times than permitted by using multiple email addresses, identities, or devices in an attempt to circumvent these Official Rules. Entry in this giveaway will not qualify as entry in any other giveaway that may be offered by Sponsor.

The Semifinalists will be notified by email and must each submit a video of themselves at least one (1) minute but no longer than three (3) minutes in length to Sponsor on or before February 15, 2022. The video must include why the Semifinalist should be chose, what they would use the prize for, and what winning the prize would mean to them.
